AGM 2010 Workshop Review

The AGM Workshop Review that was conducted at Cleveland's House in June, is available on the Website for your perusal. These workshops were very successful with a lot of creative ideas being put forth by the field.

Your Board of Directors has taken all of these ideas and has created Actions Plans for the 2010 / 2011 season and beyond.

AIL Benefit Increase

The death and dismemberment benefit, provided free of charge with the purchase of an O5 membership card, has been increased to \$3,000 by AIL. **This is a great incentive to sell membership in your Zones and DC's.**

An additional benefit is available to members returning their card -- \$10,000 at a cost of \$2 for the first year and \$5 for subsequent years.
