**Subject: 2023 ANNUAL GENERAL MEETING**

Dear President:

The 2023 Annual General Meeting of the Ontario 5 Pin Bowlers' Association will be held from **JUNE 15-17, 2023** at Fern Resort, 4432 Fern Resort Road, Orillia, Ontario, L3V 6H5. The first meeting is planned for after lunch on **THURSDAY, JUNE 15, 2023**.

The package rate will be \$199.00 plus 18% Event Services Fee and 13% HST per person per day based on double occupancy. Single occupancy will cost \$239.00 plus 18% Event Services Fee and 13% HST per person per day.

The package rate includes accommodation and ten (10) meals as follows:

Thursday – Lunch and Dinner (**Arrival Day**)  
Friday – Breakfast, Lunch and Dinner  
Saturday – Breakfast, Lunch and Dinner  
Sunday – Breakfast and Lunch (**Departure Day**)

Please note that the check-in time is 4:00 p.m. and check-out time is 1:00 p.m.

**If you want to arrive a day early (Wednesday, June 14) there will be a limited number of rooms available and you must register with the office in order to get the package rate.**
