The 2026 Annual General Meeting of the Ontario 5 Pin Bowlers' Association will be held from **JUNE 19-21, 2026** at Fern Resort, 4432 Fern Resort Road, Orillia, Ontario, L3V 6H5.

We are looking at doing a Seminar on Friday, June 19, 2026 at 10:00 a.m. (more details to be announced), with the first General Meeting #1 taking place after lunch. Attached for your information is a Draft Meeting Schedule.
